



RELEASE AND DISCLAIMER LIABILITY FOR DAMAGE OR INJURY

While using Cherry Creek Country Club, or participating in this EVENT Guest/Golfers are charged with the responsibility of using proper judgment and caution at all times. Club Management and its owners, officers, employees, affiliates, representatives and agents do not assume any liability for injuries caused to or incurred by any Guest/Golfer or for damage to or loss of property resulting from the use of The Club. Each Guest/Golfer agrees to release Club Management and its owners, officers, employees, affiliates, representatives and agents and waives any cause of action which a Guest/Golfer, or anyone claiming by or through said EVENT, might now or hereafter have against said parties due to any injuries caused to or incurred by any Guest/Golfer or for damage to or loss of property resulting from their use of The Club.

Each Guest/Golfer;

(a) is responsible for any damage to The Club Facilities, property or any person caused by the Guest/Golfer; and such Guest/Golfer shall promptly reimburse Club Management for all costs and expenses incurred to repair or replace such damaged facility or property. In the event a Guest/Golfer causes such damage, the Guest/Golfer shall immediately take responsibility for the incident and shall also report the matter to the `events representative` or Golf Shop upon completion of play or sooner as the situation may warrant.

(b) are expected to respect the rights of persons owning property adjacent to the golf course. Personal injury or property damage caused by a golf ball entering onto adjacent land is the sole responsibility of the golfer striking the ball. Club Management and its owners, officers, employees, affiliates, representatives and agents shall not be responsible for such injury or damage. In the event of such injury or damage, the Guest/Golfer shall attempt to contact the landowner or resident at the time of the incident and also report the incident to the `events representative` or Golf Shop upon completion of play or sooner as the situation may warrant.

(c) while using carts on the golf course are responsible for any injury to themselves or others which may result. Club Management and its owners, officers, employees, affiliates, representatives and agents shall not be responsible for injuries which may result from cart accidents or other conduct of persons using the golf carts. In the event a Guest/Golfer causes such injury, the Guest/Golfer shall immediately contact the injured party and take responsibility for the incident and shall also report the matter to the `events representative` or Golf Shop upon completion of play or sooner as the situation may warrant.

(d) while on the golf course **errant hit golf balls are a possibility for serious injury**. Errant hit golf balls are the responsibility of the golfer striking the ball for any injury to themselves or others. Club Management and its owners, officers, employees, affiliates, representatives and agents shall not be responsible for injuries which may result from errant hit golf balls, or other conduct of persons. In the event a Guest/Golfer causes such injury, the Guest/Golfer shall immediately assist the injured party and take responsibility for the incident and shall also report the matter to the `events representative` or Golf Shop upon completion of play or sooner as the situation may warrant.

As the situation may warrant Call 911 and report all incidents to the `events representative` or Golf Shop immediately!
